Industrial Technology.

The Committee noted in discussion that there were several courses, such as Senior Science and Mathematics, which were satisfactory in giving a basic groundwork for higher education study in a broad sense, although not necessarily being direct preparation for specific higher education subjects. They needed to be categorised according to the former rather than the latter criterion.

The Category A review process would be concluded at the next meeting of the Committee.

5. FINANCIAL STATEMENT

A statement would be provided to the next meeting.

6. CONFERENCES AND MEETINGS

The Chair agreed to obtain information regarding the next annual meeting, which is being held at University of South Australia. Ruth Foxwell obtained details of the next Governance Conference organised by the National Institute for Governance, which would be in November. She would encourage the Institute to invite Chairs directly.

7. OTHER BUSINESS

7.1 ARC Grants 2005

Linda Connor agreed that the full wording of the University of Newcastle resolutions and letter from the Chancellor to the Minister could be circulated to members. The Committee endorsed the action taken by the University of Newcastle and UTS, and agreed to revisit this matter if required after the outcome of the next ARC grants round has been concluded.

7.2 AVCC Common Vacation Weeks

This matter had originated in the UTS Faculty of Business, which was recommending that for the purposes of the academic calendar the first AVCC common week be linked to Anzac Day rather than to Easter. Reactions were mixed, with many members of the Committee pointing out that staff tend to rely on the AVCC week coinciding with the school vacation, even though these had not always coincided. It was also pointed out that the recommendation could have an adverse impact on the organisation of vacation schools across the sector. Anne Cusick reported that UWS had recently been surveyed by AVCC regarding advanced planning for common weeks. The Committee noted that UTS would forward its proposal to the AVCC as an option.

7.3 UDBEC Principles and University Engagement with Schools

The following were among the points raised in general discussion:

- regional universities may be disadvantaged in relation to UDBECs by having few large schools to draw on, and insufficient resources to establish UDBECs
- UDBECs were intended to replace Distinction courses but this had not happened in practice
- it is possible for a large and well resourced university to establish UDBECs as a student recruitment strategy
- quality assurance of UDBECs might be improved and credibility enhanced if it is a requirement that UDBECs must be recognised by more than one university
- the HECS implications need to be explored (in terms of students gaining access to HECS places and funding issues within universities).

The Committee agreed to revisit this matter in about a year's time.

7.4 Board of Studies Decisions

The summaries of decisions of recent meetings were noted.

Steering Committee for "All my own work"

The Chair sought nominations for the "All my own work" steering committee. Anne Cusick expressed interest in nominating.

7.5 Appointments to Board Curriculum Committees

The Committee discussed the draft criteria for selecting nominees for Curriculum Committees. The consensus of the group was that nominees for curriculum committees should be experts in the discipline, as opposed to being expert in the field of discipline education, and should also be able to demonstrate some effectiveness as advocates. These wishes were expressed particularly in relation to nominees for the Maths curriculum committee. The criteria would be revised accordingly.

7.6 Student Progression

Student progression information from UWS and UTS was received and noted. Anne Cusick pointed out that the progression and appeals process was a good way of testing the accuracy of the institution's student system, as errors are often uncovered. It was also noted that DIMIA now undertakes audits of particular student cases where international students have been identified as being 'at risk' academically.

On behalf of the Committee, the Chair thanked the staff of CSU and UTS for the hospitality, support, and arrangements made for the meeting, which was greatly appreciated by the group.
